BACKGROUND OF THE ORGANIZATION

Opportunity Village Nepal (OVN) is a non-governmental and non-profitable organization founded and managed by Good Shepherd Sisters. It was established in 1998 and registered in District Administration Office Kathmandu. OVN focuses on the 4P strategic intervention: Prevention, Protection, Prosecution and Partnership. The organization implements Anti-human trafficking projects in 3 different districts of Nepal Kaski, Rupandehi and Kathmandu. The organization has established child protection homes to protect children and promote their rights, especially those at risk of trafficking, sexual abuse, sexual exploitation, and labour exploitation. The Child protection home is registered with the District Child Welfare Committee, Kaski and is providing services in accord with the "Standards for Operation and Management of the Residential Child Care Home, 2012" implemented by the Government of Nepal.

Child Protection Home

OVERVIEW

Promotion of the Rights of Vulnerable Nepali Girls project is implemented in Pokhara Kaski District.

Opportunity Nepal runs a Child Protection Home providing formal and non-formal education, rehabilitation and reintegration of children and adolescents who are survivors of human trafficking and exposed to vulnerabilities. Their fundamental rights are ensured by the Child Protection Home.

The Child Protection Home is registered with the District Child Welfare Committee, Kaski and is providing services in accord with the "Standards for Operation and Management of the Residential Child Care Home, 2012" implemented by the Government of Nepal.



According to the objectives of the Child Protection Home, quality education, technical education, psychotherapeutic services, life skills, and vocational skills training are provided. The needs and development of the physical, psychological, emotional, and social aspects of the protected girls are taken into consideration and ensured.

Goal & Objectives

- ◆ Provide care and protection to 20-25 girls at risk and after-care services to the youths who are reintegrated in their families and communities.

Provide education support and Income Generation support to the families of children at risk thus prioritizing the care of children in their families.





Empower Youth to Combat Human Trafficking

In Katmandu and Kaski Pokhara, the Anti-Human Trafficking project is implemented. The project focuses on Youths working in the adult entrainment sector (AES) who are exposed to vulnerabilities such as being forced to tolerate physical, mental, financial, and other forms of violence. Adolescents and youths are at high risk of human trafficking and sexual abuse in society in AES. The

AES is a thriving sector that includes Dance Bars, Concert halls, Cabin Restaurants, Massage Parlors and Beauty Parlors. It is a sector that is fertile for under-aged children to be employed and potentially abused, tortured and exploited.

OVN intervention is towards psychosocial and economic independence and advocating raising voices against injustice. Safe Home (Transit Home) is operated to provide short-term (less than a month) and long-term (up to 9 months) residential services to those in need.

Goal

This project aims to ensure young people's right to actively and meaningfully participate particularly in social change by developing their capacity and providing a support base for socio-economic empowerment.

Target Group

- ◆ Youth who are working & engaged in the entertainment sector are being exposed to various forms of violence
- ◆ Trafficked, sexually exploited & at-risk children and youth

Objectives

- ◆ To empower young people and promote their meaningful engagement to combat human trafficking
- ◆ Survivors and children/youth at risk are supported to achieve decent and sustainable livelihood.
- ◆ Strengthened referral mechanism for sustainable reintegration and rehabilitation and enabling survivors to restore self-esteem.
- ◆ Strengthened coordination and collaboration with GOs, NGOs, CBOs, private sectors and key community stakeholders to promote and protect rights of those affected and at risk of trafficking and sexual exploitation.





CBAHT-PROJECT Overview

In Rupendei the Cross-Boarder Anti-Human Trafficking Project is being implemented. Trafficking of girls and women is taking place for various purposes and mainly for labour exploitation and sexual exploitation. Over the time period, the Cross border trafficking is not limited to trafficking to India instead it is increasingly happening overseas. To address such context, OVN is combating cross-border human trafficking through 4Ps approach (prevention, protection, prosecution and partnership).

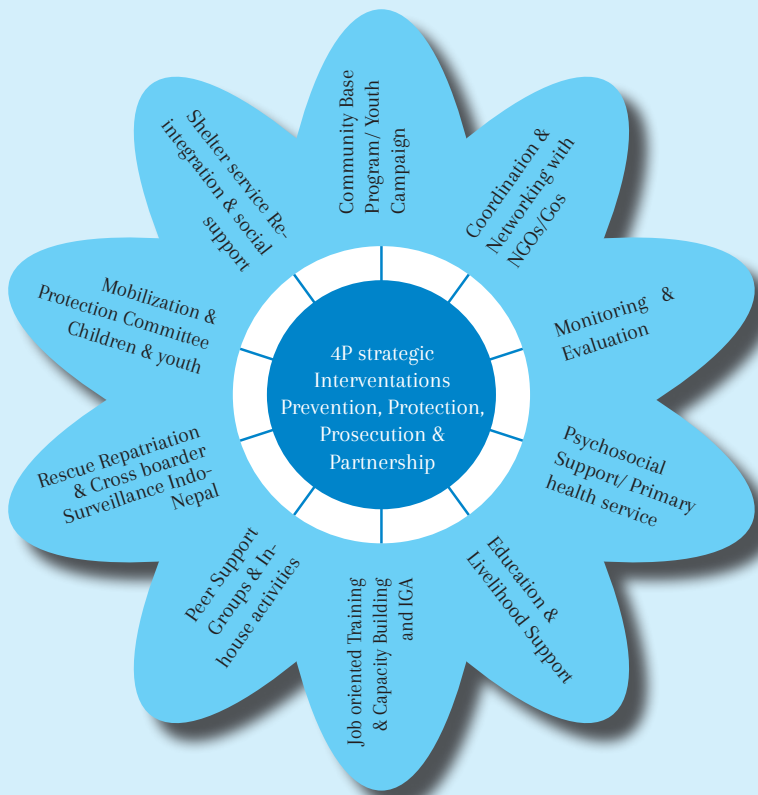
GOAL & OBJECTIVES

Prevention and reduction of trafficking of women and children and reintegrating victims of sexual exploitation into society

- ◆ Repatriation of trafficking survivors through linkages/referrals with duty-bearers and NGOs involved in rescue in India.
- ◆ Rehabilitation / Reintegration services to survivors in the safe home
- ◆ Community Awareness and Border Surveillance for timely interception of susceptible cases at the Indo-Nepal border.
- ◆ Networking and Partnership with NGO Federation, District Network of Women and Child Rights and District Level Committee on Anti-Human Trafficking
